The protection of your personal data is of particular concern to us. We therefore process your data exclusively on the basis of the statutory provisions (DSGVO, DSG, KomG). In this data protection information, we inform you about the most important aspects of data processing within the framework of our website and the Symbolon profile. We process and use your personal data exclusively in accordance with Art. 5 and Art. 6 of the DSGVO.

Contact with us

If you contact us via form on the website or via e-mail, your data will be stored by us for the purpose of processing your inquiry and in the event of follow-up questions. These data will not be passed on without your consent.

Cookies

Our website uses so-called cookies. These are small text files that are stored on your end device with the help of the browser. They do not cause any damage.

We use cookies to make our website user-friendly. Some cookies remain stored on your end device until you delete them. They enable our web and profile pages to recognize your browser the next time you visit.

If you do not wish this, you can set up your browser so that it informs you when cookies are set and you only allow this in individual cases.

If you deactivate cookies, the functionality of our website may be restricted.

Web analysis

Our website uses functions of the web analysis service of Google Inc. ("Google"). Google Analytics uses "cookies", which are text files placed on your computer, to help the website analyze how users use the site. The information generated by the cookie about your use of the website will generally be transmitted to and stored by Google on servers in the United States. However, your IP address will be shortened by Google in advance within member states of the European Union or in other contracting states of the Agreement on the European Economic Area. Only in exceptional cases will the full IP address be transmitted to a Google server in the USA and shortened there. On behalf of the operator of this website, Google will use this information to evaluate your use of the website, to compile reports on website activity and to provide other services relating to website activity and internet usage to the website operator. The IP address transmitted by your browser as part of Google Analytics is not combined with other data from Google. You can prevent this by setting your browser so that no cookies are stored.

The relationship with the web analysis provider is based on "Privacy Shield".

Data processing is based on the legal provisions of Art. 49 Para. 4 KomG and Art. 6 Para. 1 Letter a (consent) and/or f (legitimate interest) of the DSGVO.

Our concern in the sense of the DSGVO is the improvement of our offer and our web presence. Since the privacy of our users is important to us, the user data is pseudonymised.

The user data is stored for a period of 26 months.

Data security

Symbolon AG takes appropriate and appropriate technical and organizational measures to ensure the confidentiality, integrity and authenticity of your data. Irrespective of the measures taken, cross-border data traffic may occur due to the nature of the data transmission.
